Summary of Participating Union Responsibility

Participating Unions are obliged to comply with the requirements and responsibilities as specified in this Tournament Manual and should ensure that all necessary parties, in particular all Team Members, are familiar with the contents.

Participating Unions are responsible for the actions of all persons under their control as defined in the Participation Agreement and are accountable for the compliance of those persons with the Terms of Participation.

Participating Unions are subject to penalties for any breach of the specifications of these Terms of Participation.

Participation Agreement

All Unions that take part in Asia Rugby Tournaments shall be required to complete a Participation Agreement.

Withdrawal at Short Notice

Unions that withdraw from a tournament at short notice (within 1 months of the start date) may be subject to sanctions. (See Section 14)

International Travel Costs

Each team (unless the union owes Asia Rugby any financial sanctions) will be provided with a USD 1,000 travel stipend. The said stipend is the full contribution of Asia Rugby towards the Participating teams travel costs.

Any overage in travel costs will be the sole responsibility of the Participating Union. This shall include all airfares, visas, baggage costs and insurance (to include home repatriation) so as to arrive at the nearest agreed international airport/port/location one day before the start of the first match day.

Squad Composition

12 players + 3 team officials (including 1 team medic whom is World Rugby certified in L2 ICIR, for

a total of up to 15 people.

Each team will have 7 double rooms and 1 single room from lunch time the day before the tournament until breakfast the day after the tournament.

Age Eligibility

✓ Players must be under 18 and 16 years old on the 1st day of competition. So player must be born between:

1st January 2005 – 30th September 2007

Insurance Cover

Asia Rugby expects that Unions must take out appropriate insurance (medical, hospital and medivac) for teams participating in Asia Rugby sanctioned competitions, which should include home repatriation.

If the Union is not able to provide the appropriate insurance, the no insurance declaration form must be completed and submitted to Asia Rugby Competitions Consultant prior to the start of any competition or tournament. Failure to provide the no insurance declaration form will result in the Union's team/s not being allowed to participate in the competition or tournament. Unions agree that in the event of no insurance, Asia Rugby shall be indemnified from any and all liability incurred as the case may be.

Entry Visa

Participating Teams are responsible (including all costs) for entry and exit visas (as applicable).

Travelling Union may request an invitation letter from the Host Union but ***have the ultimate responsibility to secure visas in time to travel.***

Provide 2 sets of kit (different colours)

Unless agreements have been made beforehand, each team must supply two sets of different coloured playing kit. The kit must be numbered in accordance with World Rugby Regulation 15 (15.18) (<https://www.world.rugby/organisation/governance/regulations/reg-15>) with numbers clearly visible throughout. Any advertising on the kit must be World Rugby compliant www.world.rugby
